The undersigned (on my own behalf and on behalf of my heirs, next of kin, personal representatives, successors, executors, and assigns), for and in consideration of the opportunity to participate in a "Ride", and/or "Event" (hereinafter EVENT(S)), sponsored by WITW Sol Sisters San Diego Chapter and their respective officers, members, agents, and volunteers (hereinafter RELEASED PARTIES) releases and holds harmless the RELEASED PARTIES from any and all claims and demands, rights and causes of action of any kind whatsoever which I now have or later may have against the RELEASED PARTIES in any way resulting from, arising out of, or in connection with my participation in any said EVENT(S).

This release extends to any and all claims I have, or later may have against the RELEASED PARTIES whether or not such claims result from negligence (except willful neglect) on any part of any or all of the RELEASED PARTIES with respect to the EVENT(S) or with respect to the conditions, qualifications, instructions, rules or procedures under which the EVENT(S) are conducted or from any other cause. I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL OF THE RELEASED PARTIES FOR ANY INJURY RESULTING TO MYSELF OR MY PROPERTY ARISING FROM, OR IN CONNECTION WITH SAID EVENT(S).

Should I elect to participate as a passenger in an event motorcycle ride, I acknowledge my responsibility to ensure that the driver of the motorcycle is appropriately licensed, insured and without impairment. The RELEASED PARTIES do not perform any inspection or test drivers. I am not relying on any belief that the RELEASED PARTIES are in any way responsible for the actions of the party with whom I elect to ride as a passenger.

\_\_\_\_\_ I certify that I am experienced in and familiar with the operation of motorcycles and fully understand the risks and dangers inherent in motorcycling. I certify that there are no health-related reasons or problems which preclude my participation in this activity or event. I certify that I have a valid driver's license with motorcycle endorsement (2-wheel motorized vehicle) as required by the State of California. I certify I have valid motor vehicle insurance as required by the State of California. I am voluntarily participating in the EVENT(S) and I expressly agree to assume the entire risk of any accidents or personal injury, including death, which I might sustain to my person and property as a result of my participation in the EVENT(S), whether or not such risk results from negligence (except willful neglect) on the part of any or all of the RELEASED PARTIES.

\_\_\_\_\_ I agree that I will not ingest any alcoholic beverage, substance or drug (legal or otherwise) that may adversely affect judgment or physical coordination before or while participating in any EVENT(S) or any other activity in which alcohol or such substances could adversely affect the ability to operate a motor vehicle.

**WAIVER OF RIGHTS UNDER STATE STATUTES**

I further agree to waive all benefits flowing from any state statute which would negate or limit the scope of this Release and Indemnification Agreement, including, but not limited to, Section 1542 of the California Civil Code which provides:

"A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party."
